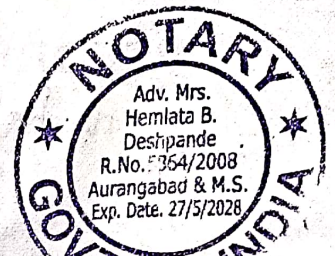
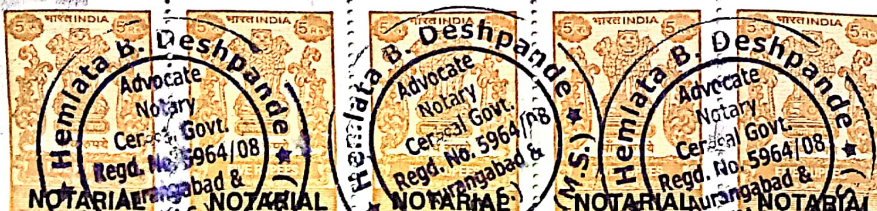

Introduction: I am authorized to make this affidavit on behalf of Kai Wamanrao Pitambare Arts,Commerce & Science College, and I am well-versed with the facts stated herein.

Context: As per the recent developments regarding the BBA (Bachelor of Business Administration) and BCA (Bachelor of Computer Applications) programs, it has been announced that these programs will come under the purview of the All India Council for Technical Education (AICTE) starting from the academic year 2024-25.



Current Status in Maharashtra: In Maharashtra, these programs are presently managed under the jurisdiction of the Higher Education Department and are affiliated with the respective affiliating universities. This structure remains in place until such time as an official circular or directive mandates a transition to AICTE's purview.

Compliance with AICTE Approval: We acknowledge that from the academic year 2024-25, AICTE approval will be mandatory for BBA and BCA programs. However, as of now, there has been no circular or formal notification from the AICTE or other relevant authorities indicating that we must obtain AICTE approval immediately.

Future Compliance: We assure that upon receipt of any official circular or notification regarding the transition to AICTE's purview, **Kai Wamanrao Pitambare Arts, Commerce & Science College** will diligently follow all prescribed procedures and complete all necessary formalities to obtain AICTE approval for the BBA and BCA programs.

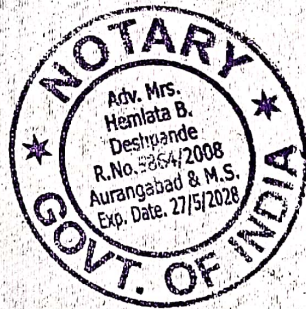
Current Procedural Conflict: We understand that there is an existing procedural conflict in Maharashtra regarding whether these programs fall under the Directorate of Technical Education (DTE) or Higher Education Institutions (HEI). As of the current guidelines, these programs are still part of the affiliating university system.

Commitment: We commit to keeping abreast of all relevant updates and ensure compliance with AICTE requirements as soon as they are officially communicated. We will take all necessary steps to align with AICTE regulations once the official circular or directive is issued.

Declaration: This affidavit is executed to declare our understanding and intention regarding the transition of the BBA and BCA programs to AICTE's purview and to confirm our commitment to comply with future regulations.
